# Page 2 - Questions for Panelists (3-4 Minute Reply)

- Mr. Bazaj: Commercial and industrial customers are increasingly announcing aggressive carbon reduction goals to meet sustainability targets during a time of extreme market volatility. What strategy changes has Constellation seen companies employ to lower their carbon footprint?
- Mr. Castro: How does expanded availability and access to smart meter data for customers and retail suppliers like Dynegy impact energy usage, cost management and optionality for competitive supply products?

- 1. Mr. Holt: The Consumer Energy Alliance describes itself as "the leading voice for sensible energy and environmental policies for consumers." Can you tell us a little more about the Alliance? How does the organization parse what makes for a "sensible" policy?
- 1. **Mr. Levine**: As a global energy supplier with a robust Ohio presence, how does **ENGIE view the competitiveness of energy here in Ohio** in the context of recent geopolitical turmoil and global energy crises?
- Mr. Melink ~ You've authored the book Fusion Capitalism, a Clean Energy Vision for Conservatives. Conservatives often shudder at the thought of the government picking winners and losers in the marketplace. How is the electrification movement affecting the Ohio economy and what is government's role?
- Mr. Proaño: You bring a legal and regulatory perspective to these issues, as a lawyer representing different entities in the energy markets before the PUCO, in a range of matters and on a variety of issues. How do you view the intersection of the law and energy markets, and how do the legal and regulatory frameworks in place for the provision and delivery of energy impact the energy markets?

On December 23, 2022, Winter Storm Elliott plunged Ohio into a deep freeze – including more rural areas of the state that principally rely on electric heat. At hour-ending 6 pm, the AEP Zone registered its highest hourly load since 2015. Provide us your assessment of grid conditions during this time period and what resources helped prevent a crisis like what was seen in Texas during Winter Storm Uri. What does Ohio and PJM need to do to ensure continued grid reliability in extreme conditions?

3. Ohio's Standard Service Offer (SSO) is the default price customers pay that do not elect to competitively source power. Because of the timing of SSO auctions, SSO prices have been below market since late Summer 2021. As a result, we have seen a mass migration of customers – ranging from residential and small commercial government aggregation to some of Ohio's largest energy users – defaulting to the SSO. How long does this remain a viable strategy for customers and when should consideration be given to reentering power supply agreements with Competitive Retail Electric Service suppliers?
